## The Speakers (in alphabetical order):



Deputy Director of International Cooperation & External Relations, Ministry of Culture, Tunisia

**Bilel Aboudi** has served as a Public Services Advisor at the Ministry of Culture of Tunisia since 2001. As a public policy specialist, he was assigned in his early career to elaborate a new cultural policy framework based on development projects. Later, he was responsible as a negotiator and as a cultural policy specialist for development oriented international cultural cooperation, namely at the multilateral level (International and regional organizations).

Since its elaboration in 2004, he actively participated in the UNESCO convention for the protection and the promotion of the diversity of cultural expressions as a Vice-chairman, as an international expert and as a UNESCO programme specialist. He graduated from Bilkent University (Turkey) in Management and Business administration, and has a Diploma of High Studies (Master) from the National School of Public Administration (Tunisia) specialized in development projects and policy analysis.









In addition to work in music composition, film and radio, Alexis Alatsis has spent time in the opera world, in such international venues as the Teatro Comunale in Florence, Italy, the Staatsoper in Hamburg, Germany, the Accademia Musicale Chigiana in Siena, Italy, and the Teatro La Fenice in Venice, Italy, working mostly on contemporary or baroque operas. In the U.S., Alexis directed and managed the 20th century opera of Maurice Ohana "Three Stories of the Honorable Flower" at La MaMa E.T.C. in New York. For many years he was a permanent member of the managing team of KAMPNAGEL International Theatre Centre in Hamburg, Germany, with participation in the planning and production management of many international Festivals. He was the Section Manager for Culture of the Organising Committee for the ATHENS 2004 Olympic Games and the Artistic Director of the Patras 2006 - European Capital of Culture and of the Michael Cacoyannis Foundation in Athens. He was also dramaturge at the Theatre Technis - Karolos Koun in Athens. He translated many contemporary plays from several languages into Greek. In 2011 he was the invited master artist in the Directors Lab at the Lincoln Centre in New York. He currently leaves in Athens, Greece, working as a director. As a theatre director he mostly directed contemporary plays (by Heiner Müller, Bernard-Marie Koltes, Sarah Kane, Elfriede Jelinek, etc.) but also new approaches of ancient Greek Tragedy.



**Nick Barley** worked in London as a publisher and editor of arts books and magazines throughout the 1990s. The magazines under his stewardship included Blueprint (for architects and designers) and he was responsible for the launch of Tate, the art magazine in 1992. Nick moved to Scotland to become editor of the cultural magazine The List in 2003, and he was winner of the PPA Editor of the Year Award in 2005.

Since October 2009 he has been director of the Edinburgh International Book Festival, which takes place each August. Under his direction the Book Festival has launched a series of innovations including Unbound, a free minifestival of literary performances, the Anobii First Book Award, the 2012 Edinburgh World Writers' Conference and the Word Alliance, a network of eight of the world's leading literature festivals.

He is also a visiting Professor at Edinburgh Napier University and in 2012 he was a judge of the Independent Foreign Fiction Prize.









**Kateryna Botanova** (Ukraine) is an art critic, curator, contemporary culture researcher and cultural producer. Since 2009 director of CSM-Foundation Center for Contemporary Art (Kyiv, Ukraine) and founder and chief editor of the online journal on contemporary culture KORYDOR. Works with issues of social engagement of art and the role of art in societies' transformative processes.

She lectures on contemporary art, cultural management and cultural criticism. Since 2013 curates a special program "Non-practical stuff for entrepreneurs" at KMBS (Kyiv Mohyla Business School). In 2010 she was on the expert team developing the EC Eastern Partnership Cultural Program. Member of the Board of the FLOW festival (2009), European Cultural Parliament (2007), Vienna Seminar Steering Group (ERSTE Foundation 2012).

As cultural journalist and cultural section editor she worked for most major magazines and TV channels in Ukraine. Holds MA in Cultural Studies from the National University of Kyiv-Mohyla Academy (Kyiv, Ukraine).

In 2009 her Ukrainian translation of Edward Said's *Culture and Imperialism* received Ukrainian Book of the Year award. Her translation of Vitaly Chernetsky *Mapping Postcommunist Cultures*. *Russia and Ukraine in the Context of Globalization* was published by Krytyka publishers in 2013.



**Uffe Elbæk**, Member of the Danish Parliament and former Minister for Culture. In 1991 Uffe Elbæk founded the KaosPilots - International School of New Business Design and Social Innovation and he was for the next 15 years the principal of The KaosPilots. The KaosPilot school inspired the creation of several international schools located in Norway, Sweden, the Netherlands and Switzerland.

From 2007 to 2009, Uffe Elbæk served as the CEO for the 2009 World Outgames. In 2010, Uffe Elbæk founded the consulting company Change The Game with the focus on leadership training, political campaigning and social innovation concepts. One year later Uffe Elbæk was voted in to The Danish Parliament for The Danish Social Liberal Party and was Minister for Culture from 2011 to 2013.

Uffe Elbæk is also on the board of several Danish and international organizations, and has over the years received numerous honors and awards, ranging from his appointment as ambassador for the local premiere league football club AGF to Knight of the Dannebrog.









Fredrik Elg works for the Swedish Arts Council. He has a background in film and photography and worked for some years as a freelance producer. Having initiated the ICORN-guest writer programme for persecuted writers in his hometown Malmö, he endorsed a close relationship between the city's cultural scene and the guest writers. Acknowledging the importance of being sensitive to the writer's experiences, the initiative proved successful. Fredrik was then asked to be the editor of a manual for Swedish ICORN-cities as well as promoting the growing movement of shelter cities in Sweden, as project manager for the Swedish Arts Council.



Julia Farrington - Head of Arts at Index on Censorship.

This year Julia organised 'Taking the Offensive – defending artistic freedom of expression in the UK' at London's Southbank Centre; 'The Art of Transition' a symposium on artistic freedom of expression in Burma and contributed to an artist-led project promoting artistic freedoms in Addis Ababa. Julia is on the Artsfex steering group, a new international network supporting artist freedoms and last year organised a meeting between English, Turkish and Danish colleagues, in a joint Arts Council England, Arts Council Denmark pilot project, exploring cross border support for artistic freedom. She developed Tripwires youth programme using peer-led theatre workshops to engage young people in free speech debates, which will tour UK tour this Autumn. Julia started out as a freelance musician and before joining Index in 2009, she programmed the award-winning music venue Union Chapel in London for 7 years.



**Adéla Foldynová** (1986) works currently as a project manager at Košice European Capital of Culture 2013, Košice, Slovakia. She is a head of the international residency program facilitating mobility and exchange of artists. The program is focused on site specificity of created works which reflect the experience from staying in a new environment.

Earlier she worked for Amsterdam based office for cultural innovation called Non-fiction providing cultural institutions with strategies and consultancy. She has also experience of working in audience development and cultural education in several Prague galleries and museums (National gallery in Prague, DOX Centre for Contemporary Art, Kampa Museum etc.).

She studied Cultural Management & Policy at Maastricht University, the Netherlands.









Claire Fox is the director of the Institute of Ideas (IoI), which she established to create a public space where ideas can be contested without constraint. Claire initiated the IoI while co-publisher of the controversial and ground-breaking current affairs journal LM magazine (formerly Living Marxism). The IoI has since worked with a variety of prestigious institutions in Britain and abroad. Claire convenes the IoI's flagship event, the yearly Battle of Ideas festival, which takes place in London in October. The IoI has also established the prestigious Debating Matters competition.

Claire is a panellist on BBC Radio 4's <u>The Moral Maze</u> and is regularly invited to comment on developments in culture, education, politics and the arts across the whole range of media outlets: such as <u>BBC Question Time</u>, <u>BBC Any Questions?</u>, SkyNews Review, and <u>BBC Breakfast</u>. Claire writes regularly for national newspapers. She has a monthly column in the <u>MJ</u> (municipal journal).

Claire previously worked as a mental health social worker and as a lecturer in English literature. She was a judge on the panel for the Orange Prize for Fiction. Claire was number 64 in *Time Out*'s 2006 <u>London Movers and Shakers</u> list, and was named the capital's No.3 activist. Claire also features in the *Telegraph*'s list of <u>Britain's 100 most influential people on the Left</u>.

Claire has a particular interest in education and social issues such as crime and mental health. She opposes any form of restriction on free speech, the erosion of civil liberties. She is also a passionate supporter of the arts, and strongly believes that they should be valued for their own sake rather than as instrumental means to social ends.



Dr **Tiffany Jenkins** is a sociologist and cultural commentator. She writes a regular column in the Scotsman newspaper on cultural issues and is a frequent broadcaster.

Her academic research explores contested authority in the cultural sector, cultural value, cultural diplomacy, contestations over heritage, and cultural property issues such as repatriation. She is the author of 'Contesting Human Remains in Museum Collections: The Crisis of Cultural Authority' (Routledge, 2011) and is currently writing: 'Keeping Their Marbles: How the Treasures of Antiquity Ended Up in Museums – And Why They Should Stay There'.

She is the Culture Section Co-Editor of Sociology Compass, and coconvener of the British Sociological Association study group, Sociologists Outside Academia. Previously she was a visiting fellow at the London School of Economics, and the arts and society director of the Institute of Ideas.









Professor **Gayle McPherson** holds a Chair in Events and Cultural Policy within the School of Creative and Cultural Industries at the University of the West of Scotland (UWS). Her research interests revolve around the interventions of the local and national state in events and festivity of all types and the social and cultural impacts of events on communities. She has just completed the Evaluation and Impact of London 2012's Cultural Programme in Scotland for Creative Scotland. She is a former Board member of Creative Scotland has served as a cultural advisor to Glasgow 2014 Commonwealth Games bid team and currently sits on the Board of two arts and theatre organisations in Scotland. She is a reviewer for many international journals in culture, policy and tourism and is an expert reviewer for grant awarding bodies in the areas of cultural policy, social science and events world wide.

She is a regular keynote speaker at international conferences and has published widely in the events, culture and festivals area, including: as a coeditor 'Research themes in Events' (2013), Cabi; as co-author of 'Event Policy: From Theory to Strategy' with Routledge (2011) 'Policy Pragmatism: Qatar and the Global Events circuit' (2012) and Events Policy: the Limits of Democracy (2011); as a co-editor of *National Days: Constructing and Celebrating National Identity*, Palgrave MacMillan (2009), "*Parading Conspicuous Identity: St Patrick's Day, New York*" (2009).

Since graduating with a Bachelor of Arts (Visual Arts) in Melbourne, Australia, **Magdalena Moreno** has developed her professional practice in the area of international cross-cultural development, cultural diversity and arts agency.

Magdalena has presented at nearly 30 conferences and seminars. She has represented Australia and Chile on a range of arts board and advisory committees of various institutions related to the promotion of the arts and cultural diversity.

Magdalena first served as General Manager of the Victorian College of Arts Gallery, University of Melbourne; as General Manager and then Executive Director of The South Project initiative; and most recently as Chief Executive Officer for Kultour, an initiative of the Australia Council for the Arts, responsible for advocating for cultural diversity in the arts in the field of public policy and through the development of intercultural programs.

The Consejo Nacional de la Cultura y las Artes (National Council for Culture and the Arts) is the government body responsible for implementing public policies for cultural development.









**Mshai Mwangola** is a performance scholar who is also an oraturist, actor, director and storyteller. She holds a doctorate in Performance Studies from Northwestern University, (USA); a Masters of Creative Arts from the University of Melbourne, (Australia); and a Bachelor of Education from Kenyatta University, (Kenya). With a career stretching over 25 years, she has performed and conducted and her academic interests and experience include performance and cultural studies, education and the arts.

In 2013, Dr. Mwangola presented a paper at the final gathering of the three year "Culture and Development UN-IDEP workshop series, which took place within the 2013 edition of FESPACO in Burkina Faso and was the featured artist-presenter at the fifth Mwalimu Julius Nyerere Intellectual festival at the University of Dar es Salaam, Tanzania. She also directed a two-week course, "The Artist as Peacebuilder" for the African Centre for Peace and Security Training in Ethiopia.

Dr. Mwangola serves as the Chair of the Board of Trustees of Uraia Trust (the Kenya National Civic Education Programme). She is a member of the International Advisory Board of the Sidensi Trust (UK), and the African Advisory Board of the Global Philanthropy Alliance. She is the Research and Communication Officer with the African Peacebuilding Network Hub in Kenya.



Milena Oda is an award-winning author, newspaper editor, radio writer, theater director, playwright, teacher, video artist, linguist, and translator, with several published works (novels, short stories, plays, articles, translations and poetry.) She has held a number of posts in Germany and the Czech Republic and is fluent in Czech, German and English with excellent French, Italian, and Russian skills. She published her first novel Nennen Sie mich Diener (Please Call Me Servant) in Germany, as well a bilingual short story book Ferenc, in German and Czech, which was produced on stage in Prague. A theater reading of Ferenc in Czech and German language will occur at the Czech-German Cultural Festival in November 2013 in Dresden. She has conducted workshops / residencies in a number of countries, including the USA and has been awarded with a prestigious scholarship at the Academy of Arts in Berlin and nominated for Ingeborg-Bachmann Prize in Austria. She is a Member, Central European Forum, Germany and a Patron of videoculture.cz, a video workshop for creative young people.



Luís Tavares Pereira was born in Lisbon, 1966. He graduated with an M.Arch from Princeton University in 1996 with a thesis on urban infrastructures and architecture, through a scholarship Gulbenkian/Princeton University, after graduating from the architecture school of University of Porto (FAUP, 1991). He is the founding partner of [A] ainda arquitectura, (Porto, 1998) an architecture studio with a relevant practice in collaboration with cultural institutions, including Serralves Contemporary Art Museum, at Porto







and Georgian National Museum, at Tbilisi. He was Vice-President of the Portuguese Order of Architects – Northern Chapter (OA-SRN), 2008-2010, where he coordinated the development of the new "Norte 41°: Centre for Architecture, Creativity and Sustainability", and member of the board of OA-SRN co-responsible for Culture Programming, 2005-2007, where he coordinated the "in transit" lecture series, the "reunião de obra (site meeting)" exhibition series, the "Road to Wonderland: young Portuguese architects" lecture/debate series, or the "Art Museums" international Symposium at Serralves, and other programs.

Luis is also a freelance curator including such projects as "Metaflux: two generations in portuguese recent architecture" for the Venice Biennale, 2004 (by appointment from the Portuguese Ministry of Culture); the Guest Countries' Section and the Conference "The Heart of the City"for the 1st Lisbon International Architecture Triennale 2007, "Chain

Reaction:Transformations in Hotel Architecture" and "Toll Free: European Architects in Transit", Ministry of Economy and Innovation / Portugal Tourism Board / Serralves Museum, 2007/2008; the multimedia project "Records of a Transformation" on the urban transformation of Porto 2001, and the Prototypo Architecture Seminar "Performing the city", Porto, 2001, for Porto 2001, European Cultural Capital.

Luis was member of the Advisory Committee of the ADDICT (Northern Portugal Agency for the Development of the Creative Industries), and is founding member of Casa da Arquitectura (the future Museum of Architecture at Porto), and observatory member of the European Cultural Parliament.

Stelios Virvidakis was born in Athens in 1955, He studied philosophy at the University of Athens, at the University of Paris I, and at Princeton University, where he was awarded his doctoral degree. He has taught at various Universities in Greece, Cyprus, France, South Korea and Japan and is currently a Professor of Philosophy at the University of Athens. He has published a book in metaethics (*La robustesse du bien*, Nîmes: Jacqueline Chambon, 1996), textbooks for Greek highschools and many articles in Greek, in French and in English, in scholarly journals, in conference proceedings and in philosophical dictionaries and encyclopaedias. His current research interests include issues in epistemology, metaphilosophy, ethics, the history of modern philosophy and the philosophy of literature.



Josip Zanki was born in Zadar on 14th March 1969. He grew up in the village of Privlaka, North West of Zadar, in a family of fishermen and farmers. He graduated from the Academy of Fine Arts in Zagreb in 1994 (class of Professor Miroslav Sutej) with a thesis entitled "Mysticism in the Artistic Practice of J. Beuys" and an experimental series of etchings "New Machines", a remake of the research conducted by the renaissance scientist Faust Vrancic. Since 1986 he has been working on installations, performances, experimental film and video and in the research into graphic media.
